FOOD VENDORS

Vendors may choose to arrive either Thursday or Friday. Food sales may begin Thursday at 5pm or Friday at 2pm.

Thursday, September 26

8-10am.... All food vendors serving food from trailers must arrive with trailer set up complete by 10am. (Areas must be covered until food sales begin at 5pm on Thursday.)

10am.... All other food vendors may arrive. (Areas must be covered until food sales begin Thursday at 5pm or Friday at 2pm.)

Noon.....Kankakee Health Department inspections begin.

Friday, September 27

8-10am... All food vendors serving food from tents must arrive with set up complete by 10am.

Noon.....Kankakee Health Department inspections begin.

Please enter festival at Division and Main Streets. Unload in a timely manner and remove your vehicle at Third and Main Streets. No one will be allowed to park on Main Street.

Please complete the application form and submit required documents with a return date no later than August 5, 2019. All booth spaces will be reserved on a first come, first served basis with restrictions to types of foods served.

Permits and Insurance Certificates

- Temporary Food Service Establishment License
 - **It is the vendor's responsibility to obtain** the proper Kankakee County Health Department permits. Please visit them online at www.kankakeehealth.org. Kankakee Health Dept. Licenses 2390 W. Station St. Kankakee, IL 60901 (815) 937-3560
 - Kankakee County Health Department permits must be displayed in your booth during festival hours of operation. There will be no refunds of application fees if your license is revoked at any time during the fest.
- Certificate of Insurance
 - **It is the vendor's responsibility to** provide a Certificate of Insurance verifying current Commercial General Liability (including product and completed operations liability) with a minimum line of \$1,000,000 per occurrence.
 - Certificate of Insurance must include **the following insured's for this event:**
 - The Village of Manteno
 - Manteno Oktoberfest, Inc.
 - Certificate of Insurance must be returned with your application.

Rules and Regulations

- The Manteno Oktoberfest Committee and the Village of Manteno will not be held responsible for any loss of goods or damage to property, or be responsible for any injuries to vendors.
- The Manteno Oktoberfest Committee reserves the right to reject any application request. Full payment will be returned with any rejected application.
- All vendors will receive a notice of acceptance or denial of requested space from the Manteno Oktoberfest Committee.
- All vendors must have a #10 fire extinguisher on sight in order to sell hot food.
- Food vendor spaces are **10'dx20'w**.
- All vendors must furnish their own shelter, tables, chairs, extension cords and water hoses. All equipment must fit inside your booth space.
- Vendors will furnish their own beverages to sell, if desired. Water will be available from a spigot for general use.
- Vendors may sell only items approved in their applications.
- Supply trailer parking is strictly prohibited on Main Street or within boundaries of festival.
- For food vendors using trailers, only one trailer per business with side service window unless otherwise approved by Manteno Oktoberfest Committee.
- There will be no refunds for cancelling any application.
- There will be no refunds for inclement weather.
- You may NOT sell corn dogs, cotton candy, popcorn or funnel cakes.
- Grease disposal is your responsibility. Do not use garbage cans or port-a-potties.
- Disposal of trash in the public garbage cans is strictly prohibited. Dumpsters will be provided and are located on east side of festival.
- Failure to comply to any of the above will result in loss of deposit.
